I explained to the interviewer the reason and the extreme importance to all citizens, if the Presidential Commission recommendation were ever acted upon. This show airs daily for an hour in the Tri-Cities area. From all the feedback I have received so far, I think the listening audience received the message and will hopefully assist in this challenge that we all have.

Area 11 Director, Mike Wekwert set up the next function I was at. This was a town hall meeting in Saint Ignace and was well attended. There was a representative from Congressman Stupak's office, along with the city's Mayor and members from the city council. Also in attendance were local citizens, members from two media papers, along with postal clerks, city and rural carriers. I thought this meeting went very well and I am assured that these people will follow up with letters or whatever else they can do.

Along with MPWU State Retiree Chapter President Al Labrecque, myself, and Mike Wekwert, we held the next town hall meeting in Alpena. At this meeting, there were some of the same people stated previously, but there was also a group from the local Democratic Party there to hear our concerns. As we all know, we have to get this word out to not only the rural areas, but also in all of our cities. Any closing will have a huge impact, not only on small rural towns, but for everyone. We have another meeting planned for Gaylord in January along with another in Sault Saint Marie.

I have noticed that if you ask many of these concerned citizens, they have no idea what is forthcoming and the possibilities that they may face in the future. So for any of you, no matter what the size of your city, contact local authorities and get them involved. Go to a council meeting, meet with the mayor and the local elected officials. They will be there to back us up and you know for a fact that they will be concerned about the

future of their mail delivery.

In the last edition of the Michigan Messenger, there were sample letters for you to send to your Senators and Congressperson. Make sure you write! Tell them how it will personally affect you, your family, and your community. When sending these letters out, make sure you send them to a local office of these representatives, because if they go to Washington, it takes sometimes three weeks to get them through the system. We have to stay on top of this thing because as they meet in Washington on the future of the Postal Service, we do not want to be too late. You have to act not and get those letters out NOW.

Finally, after months of negotiating, we now have a signed contract for the Constitutional Convention in Lansing. The information has been posted on the state's website and is also included in this edition of the Michigan Messenger. Any changes or further updates will be posted on the website, along with future editions of the Messenger. The Holiday Inn has given us a decent package that is comparative to those in the past and I am sure that all of you will be satisfied with it. We will be on the American

### RI-399


One of the latest responsibilities I have accepted is serving as arbitration advocate for the Central Region for RI-399. Yes, RI-399 is not dead!! The training we were given was very informative and a lot of work is yet to come. One of the issues stressed in the training is the Local Inventory. Way back when, in 1992 facilities where mail handlers were employed was instructed to do a tripartite Local Inventory. The parties were to sit down and determine what work in certain operations was that of the Clerk Craft and what was mail handler. If a dispute had not been filed prior to April 29, 1992 then the work stayed in the current craft. A Local Dispute Resolution Committee (LDRC) was also to be organized. The committee was to exist of the APWU, Mail Handlers Union and Postal Management. During this training it became apparent that probably a number of plants and mail processing centers never had an inventory, or no longer have an inventory and the local committee is defunct.

As your Clerk Craft Director, I recently attended the 2003 Clerk Craft Convention, which was held in Las Vegas from October 27 through October 29th. This year's convention was the largest as far a members attending. The National Union had planned on possibly 1,800 clerks attending; however over 2,200 clerks showed up. That, in itself, tells you there is a lot going on in our craft at the Post Office, and not all of it is good.

The first day instruction dealt with Article 12, as it pertains to excessing. Since this is one of the main problems going on in our craft, interest among the attendees was high. Over many years of attending these type of workshops, one can generally hear a lot of noise or conversations while the teachers or speakers do their presentation; but for this one in particular, you could of heard the proverbial pin drop in the conference center. Much of the discussion centered on excessing in an office by section or by the unit and how your local memorandum of understand would be used in regards to your office. Conversation on the pros and cons of each, such as how if by the unit, how could we hold down the disruption of clerks leaving the office by going to a different type of job in the office. Or the other side of the coin, where you could have a window clerk with less seniority than a manual sortation clerk staying in the office and the distribution clerk being excessed out of the unit. Also discussed was the rights of Veterans as well as Union Stewards in regards to be excessed or not being excessed or in what kind of order they would go. They touched on many other factors such as residual bid positions, time-line for notifications for both the employee and the union for excessing to other crafts and to lover levels. Much information to digest.

On the second day, we talked about what is known as the "Hub Clerk" position. This came about because management was utilizing clerks in small AO offices to work in other Post Office to try to get them more hours of work. At the time, it was a good idea; but like any idea the Postal Service thinks up, it has flaws, and this was no exception. Postmasters in small offices did not want to pay for their clerks' travel time, as well as mileage, saying it was the other office that should be picking this cost up. Some of these clerks stop getting any money for this travel, which is

**Amazing Response:** In the face of an impending blizzard and high winds warning, more than 20 APWU clerks, rural and city carriers, and organization leaders from Alpena, Atlanta, Mio, Rogers City, and points between, attended a hastily put together informational forum on the Presidential Commission on the USPS in Alpena on Nov. 12th.

It was my privilege to assist MPWU Area 11 Dir., Mike Wekwert, in hosting the 'pizza' meeting where we furnished attendees volumes of information materials to educate them on the threats the Commission's report to Congress poses for postal workers, the USPS, and American mailing public.

MPWU President, Gary Van, who has been traversing the state conducting similar "Town Hall" type meetings, participated, as did Sue Adams, staff aide from Congressman Bart Stupak's Alpena District office. Citizen involvement by members of the Alpena and Montmorency Counties Democratic Parties put the success of the forum over the top.

After Brothers Wekwert, Gary Van and I made our presentations covering all the 'sins' of the Commission's recommendations; Sue Adams from Rep. Stupak's District office reinforced our APWU contentions and assured us of the 1st District Congressman's support in the U.S. House. Most importantly, Adams stressed the absolute necessity of writing Rep. Stupak and all our Members of Congress, so when the debate reaches the floors of the U.S. House and U.S. Senate, legislative Representatives (like Stupak) and Senators can have letters, faxes, and e-mails in hand to demonstrate to their colleagues constituent opposition to the Commission's proposals.

Most encouraging was a proposal by the Montmorency Dems to promote a massive letter writing campaign by furnishing members on their lists copies of letters to Members of Congress with stamped, addressed envelopes. At the close of the forum, participants absolutely astounded Mike, Gary and I by contributing an unsolicited excess of \$150. to finance postage and envelopes for the suggested letter writing campaign. I guess we really reached them! The Montmorency County Dems have already ex-



It was strongly suggested that as local leaders we need to address this issue again at the local level. The possibility of plant closings and consolidations could cause the crossing of jurisdictional lines and probable RI-399 disputes.

There was some disheartening grumbling among the trainees in the class. Too many of our Clerk Craft brothers and sisters are unwilling to do some of this work. They don't want to get their hands dirty, or they don't want to do any heavy lifting. Some day you maybe replaced with a mail handler. Think about it!!

#### USE OF GLOVES ON AUTOMATED EQUIPMENT

In case you didn't know, the APWU at the national level has been pursuing the issue of wearing gloves on automated equipment. At the request of the APWU, OSHA initiated an investigation into the USPS policy of not allowing us to wear gloves around automated equipment. The APWU asserted that gloves were necessary to protect our members' hands from hazards such as cuts and scrapes and even more important biological and hazardous material in the mail. We've just seen again recently where poison and anthrax were found in the mail.

OSHA conducted an investigation and concluded that there was no evidence to determine that the use of Nitrile gloves around mail processing equipment contributed to an increase in the number of potential hand injuries. PROTECT YOURSELF AND WEAR GLOVES.

A.M. STANDARDIZATION PILOT

In a memo dated November 5, 2003 I was notified that early next year, the Lakeland Performance Cluster would be participating in a national pilot program to standardize A.M. operations in delivery units. The pilot program is to include one plant location and all Level 21 and above offices served by the processing facility.

I have requested additional information, but have not received any thing as I write this article. I have to wonder if this is the same Delivery Pilot Program that has been going on here in the U.P. of Michigan . The program here included three (3) associate offices, Marquette, Ishpeming and Negaunee Michigan. The largest of these offices is Marquette. Management was able to reduce 4800 clerk craft hours in this office, two full-time positions. They of course think this is a huge accomplishment. They delay mail 24 hours and cut jobs out of the community. Great accomplishment!

IT PAYS TO BELONG

In November of 1998 management in the UPMPC, Kingsford, Michigan improperly reverted two manual distribution positions. Our local filed a grievance and went to the arbitration table on Dec. 6, 2002. The arbitrator sustained the grievance. Two senior employees in Kingsford bid on the jobs, which had to be reposted. The arbitrator also awarded the relief requested by the union. On October 24, 2003, management processed two pay adjustments one for \$95,578.32 and the second for \$75,868.38.

a violation of the ELM. Well, the National Union signed an agreement with the USPS making it the employee's home office, no matter how my offices you worked at, responsible for these payments of travel time, as well as mileage. Also, the home office Postmaster would be responsible for making up the schedule of the offices that the PTF would be working in. Again much talk on overtime, number of hours the employee may work in a service day, how many miles away from the home office can the clerk travel, etc. This day was as involved as the excessing class. I have copies of this agreement if anyone wants one, just call me and let me know your address.

Another item that I was glad to see finally agreed upon is that management is not allowed to issue discipline for ANY items stemming from the Mystery Shopper or any other local or district-wide program that might have been created as an offshoot of the Mystery Shopper program. In a nutshell, any program that your office or your District has come up with regardless of what they call it, (e.g. Mystery Observer, etc.) can not be the bases for discipline. This has been a pet peeve of mine from the beginning of the Mystery Shopper, that the Postal Service has said over and over again, this is not for the purpose of discipline but only a tool for Management to use to see where they need to improve their window services - Period. Management tried to circumvent this by giving direct order to the clerks to ask all the questions whether they applied or not; well, they finally put that pig to bed too. Again, I know that Postmaster in small office will try to say it doesn't apply here, or just stone wall it, but of course, I have copies of that letter too. Again, if you need a copy of your Postmaster or POOM, or for your grievance, call me, I can always make more.

panded this effort in their rural county. It's now up to us to keep this most encouraging momentum going in this mostly rural area of N.E. Michigan. This positive experience can be a blueprint for similar efforts across the state.

**Retiree Action:** I'm receiving reports from retirees across Michigan advising they have sent their letters to Members of Congress...AND I THANK THEM ALL ! Keep it up! It looks like legislation on the Commission's recommendations will hit the floors of the U.S. Senate and U.S. House no later than early Spring 2004, before election year campaigning heats up. It's **imperative** to keep up the congressional contacts now, and for the next few months! Remember; mail letters to Members of Congress to their District/Regional offices, NOT WASH., D.C. to avoid up to 6 week delays in delivery due to the ongoing anthrax screening process of mail to U.S. Government agencies in the U.S. Capitol.

**New Retirees:** The recent "early outs" have produced a virtual stampede of retired members. My home Flint Local saw a dozen 'last punch bunch' alone. **Congratulations** to all of you in your new phase in life. For those newly retired members who carry the APWU Health Plan; be advised that to remain eligible for the APWU Plan, you **must** either remain a full dues-paying member, or join the APWU Retirees Dept. for \$24. per year (\$2. per month deducted from your annuity). All newly retired members are appreciated for your years of loyal Union membership. You are encouraged to remain connected to the Union which has represented your best interests during your postal work lives by becoming a member of the APWU Retirees Dept. Just because you have stepped out of the USPS 'trenches', as long as you depend upon your CSRS/FERS annuities for your livelihood, **YOU'RE NEVER OUT OF THE ARENA!**

**SENATOR STABENOW RESPONDS:** In response to a letter to Michigan Senator Debbie Stabenow (D), on **S.623 Premium Conversion** legislation in the U.S. Senate, she responds: *"I share your support for lowering federal employees out-of-pocket health insurance premiums. I am proud to be a cosponsor of S.623, a bill that would allow Federal civilian and military retirees to pay health insurance premiums on a pretax basis and to allow a deduction for TRICARE supplemental premiums."*

*"I am also pleased to be a cosponsor of the Social Security Fairness Act of 2003 (S.349). This bill was introduced by Senator Dianne Feinstein on Feb. 11, 2003. The Social Security Fairness Act would repeal the*

*Government Pension Offset (GPO) and the Windfall Elimination Provisions (WEP). S.623 and S.349 are currently pending before the Finance Committee. You can count on my continued support of both these bills as the legislative process continues."*

These CSRS/FERS retiree 'bread and butter' issues are equally important for us to write our Members of Congress as it is to write them for their support in opposing the Commission's recommendations. Our battles are in the Halls of Congress in virtually every area. In order to prevail, everyone **must** become involved! By the way; when a Member of Congress responds in support (like Stabenow), it's important that we write a letter of "Thanks". I've sent mine to Senator Debbie. If they respond in the negative; write again asking that they reconsider their position. "The pen is mightier than the sword!"

**AARP CHUMPS SENIORS!** AARP, the organization that purports to represent older Americans, endorsed the Republican version of the Medicare drug prescription "benefit" bill. AARP has tried to justify its betrayal of seniors on Medicare with TV ads and "it's not perfect, but...." condensed crap on their [www.aarp.org](http://www.aarp.org) website. If you are a member of AARP, I recommend that you write or visit their website to vent your protest of their sell-out. As a long-time AARP member, I have assured them that they did not represent our best interests, and that I would NOT be renewing my AARP membership.

The G.O.P. Medicare prescription drug benefit bill will unravel Medicare as we know it and cause millions of older Americans to lose health coverage they already have. Bowing to the big drug companies, it does nothing to control costs and only offers a skimpy drug benefit. Here's what the G.O.P. scheme does: \*The Republicans Medicare deal opens the door to privatization by experimenting with a voucher system for Medicare in six test areas covering millions of beneficiaries. This could undermine all of Medicare. \*A \$12 billion special "slush fund" will be set up to increase the number of seniors receiving their Medicare coverage through private plans like HMO's and PPO's, forcing many seniors into private plans and deny them choice of their doctors or hospitals. \*Retirees with employer-provided coverage (like us) could lose that coverage and what we might gain would be much worse. \*Medicare's guarantee of affordable, comprehensive coverage is threatened by provisions that may force Congress to CUT Medicare benefits or INCREASE co-payments. \*For the first time ever, certain seniors will be charged new premiums based on income. \*NOTHING would be done to control the excessive price of prescription drugs that hurts so many retired

and working Americans. These provisions are a sellout to the big drug companies. (Info provided by Union Voice - Working Families e-Activist Network).

**2004 COLA:** The Cost Of Living Allowance increase in our CSRS/FERS annuities will be 2.1%. Ditto for Social Security recipients. I got this info from our local newspaper. The APWU News Service Bulletin, which used to publish quarterly retiree COLA updates, no longer reports retiree COLA's....a real rub with me.

Don't spend that 2.1% just yet! Health plan premiums increases more than gobble it up. Medicare also jumped 13.5%, from \$58. per mo. to \$66.60, an \$8.60 increase. A national APWU Legislative Rally pounding the Halls of Congress with our message to the Members of Congress is the impetus needed to get Congress' attention and fire up the rank and file at the grassroots level. I would sooner advocate spending our State Retiree Chapter funds for a Washington, D.C. Legislative Rally on our issues as funds far better expended than on a voiceless retiree junket to a national convention in Anaheim, CA!!


